
COOPERATION PROGRAMME INTERREG V-A GREECE - BULGARIA 2014-2020

PRESS RELEASE

The 4th Transnational Technical Meeting and the Steering Committee of the Project entitled: “Policies for enhancing access to Health Services in deprived Areas” (Acronym: ‘THE HEALTHY MUNICIPALITY’) will be held in the seat of Arriana Municipality, Fillyra (Rodopi) on Tuesday, 08/01/2019. The project is co-funded by 1.135.147,40 € from the Cooperation Programme Interreg V-A Greece-Bulgaria 2014-2020, (ERDF and National Funding of the countries participating in it) to improve the accessibility of people living in remote areas to the health units, while at the same time actions related to the awareness of the local population will be implemented towards acknowledging the value of prevention. Also, a series of medical examinations will lead to the creation of morbidity profile of the targeted areas and to policy recommendation for health prevention in transborder areas.

The implementation of the project started on November 1st 2017 and its duration is 24 months.
